TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of February 12, 2021, by NXT Capital, LLC, as Agent for the Lenders ("Agent").

W I T N E S S E T H:

WHEREAS, Agent and DDS LAB, LLC, a Florida limited liability company ("Grantor"), were parties to that certain Trademark Security Agreement, dated as of June 30, 2014 (the "Agreement"; all capitalized terms used herein but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Agreement), and pursuant to which Grantor granted a security interest to Agent in the Trademark Collateral, including the trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Agreement was recorded by the United States Patent and Trademark Office ("USPTO") on July 1, 2014, at Reel 5313, Frame 0048;

WHEREAS, Grantor has requested that Agent release its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral and reassign the same to Grantor; and

WHEREAS, Agent has agreed to release the entirety of its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral, including the following:

(a) all of its trademarks and rights in and to exclusive intellectual property licenses with respect to trademarks to which it is a party including those trademarks referred to on Schedule I hereto;

(b) all extensions and renewals of the foregoing;

(c) all goodwill of the business connected with the use of, and symbolized by, each trademark and each trademark intellectual property license; and

(d) all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of any trademark or any trademark licensed under any intellectual property license, (ii) injury to the goodwill associated with any trademark or any trademark licensed under any intellectual property license or (iii) right to receive license fees, royalties, and other compensation under any trademark intellectual property license.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest (if any) in and to the Trademark Collateral.
