**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK
COLLATERAL**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this “Release”) is made as of February 12, 2021 (“Effective Date”), by **WILMINGTON TRUST, NATIONAL ASSOCIATION** (as successor agent to **CITIBANK, N.A.**) (“Wilmington Trust”), in its capacity as collateral agent (together with its successors and permitted assigns in such capacity, the “Collateral Agent”), in favor of AllPaws, Inc., Pet360, Inc., PETMED, Inc., PetSmart Home Office, Inc. and PetSmart Home Support Group, Inc. (collectively, the “Grantors”).

WHEREAS, reference is made to that certain Credit Agreement, dated as of March 11, 2015, by and among, *inter alia*, PetSmart, Inc., a Delaware corporation, Argos Holdings Inc., a Delaware corporation, the other guarantors from time to time party thereto, Wilmington Trust, as Administrative Agent and Collateral Agent, and the lenders from time to time party thereto;

WHEREAS, that certain Trademark Security Agreement, dated as of March 11, 2015, between Pet360, Inc. and the Collateral Agent was recorded with the United States Patent and Trademark Office (the “USPTO”) on March 12, 2015 at Reel/Frame 5476/0498 (as amended, restated, supplemented, or otherwise modified from time to time, the “Pet360 Agreement”);

WHEREAS, that certain Trademark Security Agreement, dated as of March 11, 2015, between PetSmart Store Support Group, Inc. and the Collateral Agent was recorded with the USPTO on March 11, 2015 at Reel/Frame 5476/0041 (as amended, restated, supplemented, or otherwise modified from time to time, the “PetSmart Store Support Agreement”);

WHEREAS, that certain Trademark Security Agreement, dated as of March 11, 2015, between PETMED, Inc. and the Collateral Agent was recorded with the USPTO on March 11, 2015 at Reel/Frame 5476/0115 (as amended, restated, supplemented, or otherwise modified from time to time, the “PETMED Agreement”);

WHEREAS, that certain Trademark Security Agreement, dated as of June 30, 2017, among Pet360, Inc., PetSmart Home Office, Inc., AllPaws, Inc. and the Collateral Agent was recorded with the USPTO on June 30, 2017 at Reel/Frame 6096/0838 (as amended, restated, supplemented, or otherwise modified from time to time, the “June 2017 Agreement”; and together with the Pet360 Agreement, the PetSmart Store Support Agreement and the PETMD Agreement, the “Trademark Security Agreements”);

WHEREAS, pursuant to that certain Notice of Assignment of Security Interest in Trademarks, dated as of August 16, 2018, which was recorded with the USPTO on August 17, 2018, at Reel 6416, Frame 0767, Wilmington Trust, as Collateral Agent, succeeded to the interests of Citibank, N.A., as predecessor collateral agent; and

WHEREAS, WHEREAS, the Collateral Agent now desires to terminate and release the entirety of its security interest in the Trademark Collateral listed on **Schedule I** hereto (the “Released Trademark Collateral”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby covenants and agrees as follows:

1. Without recourse, representation or warranty of any kind or nature, the Collateral Agent hereby immediately, automatically and irrevocably terminates, releases, and discharges its security

interest in the Released Trademark Collateral, granted pursuant to the Trademark Security Agreements, and reassigns to Grantors all right, title, and interest of the Collateral Agent in the Released Trademark Collateral pursuant to the Trademark Security Agreements, and all proceeds thereof, including, without limitation, any and all causes of action which any exist by reason of infringement of the Released Trademark Collateral.


2. The Collateral Agent hereby irrevocably authorizes the recordation of this Release with the USPTO.
