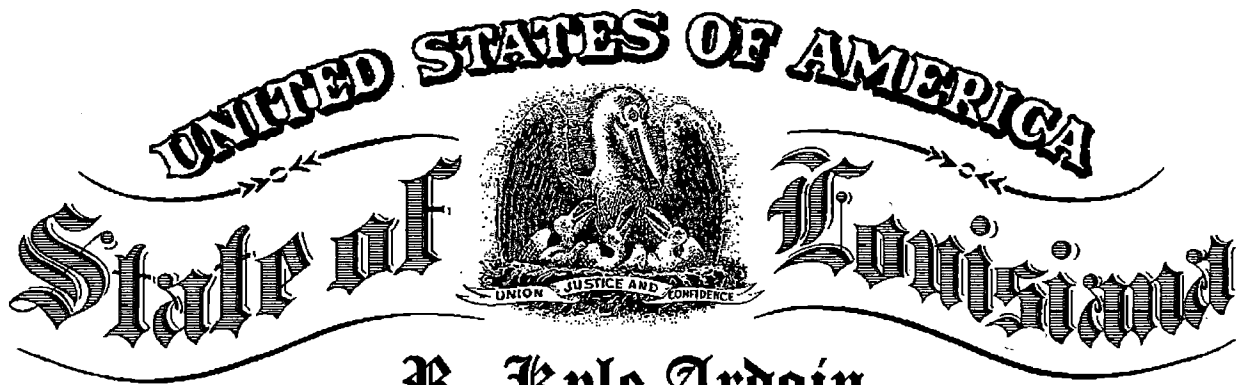


## PLAN OF MERGER

In accordance with R.S. 12:1358 of the Louisiana Business Corporation Act, as amended, **Republic Business Credit, LLC**, a Louisiana limited liability company, qualified to do business in the States of Louisiana, California, Texas and Illinois, and **Continental Republic Capital, LLC**, former known as RMSC Acquisitions, LLC, a Louisiana limited liability company, qualified to do business in the States of Louisiana, California, Texas and Illinois, desire to effect a merger, set forth the following Plan of Merger:


1. Republic Business Credit, LLC, a Louisiana limited liability company ("RBC") is a limited liability company duly organized and existing under the laws of the State of Louisiana having been organized on November 16, 2010 by the Articles of Organization filed with the Louisiana Secretary of State.
2. Continental Republic Capital, LLC, formerly known as RMSC Acquisitions, LLC, a Louisiana limited liability company ("CRC") is a limited liability company duly organized and existing under the laws of the State of Louisiana having been organized on June 28, 2019 by the Articles of Organization filed with the Louisiana Secretary of State.
3. Each of the members and managers of RBC and CRC by unanimous written consent have consented and agreed to the merger of RBC into CRC pursuant to the terms and conditions of the merger and of this Plan of Merger.
4. The surviving entity shall be CRC, which entity shall remain a Louisiana limited liability company.
5. The terms and conditions of the merger and the manner and basis of converting the membership interests of RBC into CRC upon the effective date of the merger shall be as follows:
  - (a) All of the membership interests of RBC on the effective date of the shall be cancelled.
  - (b) No new membership interests in CRC shall be issued.
6. The sole member of CRC shall continue to be SRM Capital Holdings, LLC, a Delaware limited liability company.
7. On the effective date of the merger, all of the assets and liabilities of RBC shall be assumed by CRC by operation of law.
8. No amendment to the Articles of Organization of CRC is necessary.
9. CRC shall file the Articles of Merger and this Plan of Merger with the Louisiana Secretary of State.

10. The effective date of the merger shall be the date of this filing.
