

PLAN OF MERGER

In accordance with R.S. 12:1358 of the Louisiana Business Corporation Act, as amended, Republic Business Credit, LLC, a Louisiana limited liability company, qualified to do business in the States of Louisiana, California, Texas and Illinois, and Continental Republic Capital, LLC, former known as RMSC Acquisitions, LLC, a Louisiana limited liability company, qualified to do business in the States of Louisiana, California, Texas and Illinois, desire to effect a merger, set forth the following Plan of Merger:

- 1.
