**STATEMENT OF CONVERSION  
OF  
THE AEGIS TECHNOLOGIES GROUP, INC.**

The Aegis Technologies Group, Inc., an Alabama corporation (the "Corporation"), for the purposes of converting the Corporation to an Alabama limited liability company pursuant to the provisions of Sections 10A-1-8.01 and 10A-5A-10.01 et seq. of the Alabama Business and Nonprofit Entity Code (the "Alabama Act"), hereby executes the following Statement of Conversion:

1. The name of the Corporation is The Aegis Technologies Group, Inc., an Alabama corporation. The Alabama Entity ID Number of the Corporation is 126-793.

2. The Corporation was formed on the 29th day of September, 1988, under the name of Aegis Research Corporation by filing a Certificate of Formation in the Office of the Judge of Probate of Madison County, Alabama (the "Probate Office"). Articles of Amendment to the Articles of Incorporation were filed with the Probate Office on October 26, 1999, changing the name from Aegis Research Corporation to The Aegis Technologies Group, Inc. Articles of Amendment to the Articles of Incorporation were subsequently filed with the Probate Office on July 9, 2009.

3. The Corporation has been converted to an Alabama limited liability company pursuant to Sections 10A-1-8.01 and 10A-5A-10.01 et seq. of the Alabama Act.

4. The name of the business entity to which the Corporation has been converted is "The Aegis Technologies Group, LLC", a limited liability company governed by the State of Alabama.

5. The location and mailing address of the principal office of The Aegis Technologies Group, LLC, is 410 Jan Davis Dr NW, Huntsville, AL 35806, and the Registered Agent is Steven Hill.

6. The conversion of the Corporation has been duly approved in accordance with Sections 10A-1-8.01 and 10A-5A-10.01 et seq. of the Alabama Act.

7. There is at least one member of The Aegis Technologies Group, LLC in accordance with Section 10A-5A-2.01 of the Alabama Act.

8. The conversion of the Corporation to an Alabama limited liability company shall be effective upon the filing of this Statement of Conversion.
