TERMINATION OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

WHEREAS, Aquarius Rags, LLC, a California company corporation with its principal place of business at 1218 S. Santa Fe Avenue, Los Angeles, CA, 90021 (the "**Grantor**"), is the owner of record of these trademark registrations in the United States Patent and Trademark Office (the "**Trademarks**"): A·B·S By ALLEN SCHWARTZ, registration no. 2663907, A·B·S By ALLEN SCHWARTZ, registration no. 2557558, ABS, registration no. 2228025 and ALLEN B, registration no. 2686864.

WHEREAS, the Grantor's predecessors in interest, The Warnaco Group, Inc. and certain of its subsidiaries, entered into the Intellectual Property Security Agreement dated October 6, 2000 (the "**Security Agreement**"), between The Warnaco Group, Inc. and its subsidiaries and State Street Bank and Trust Company as Collateral Trustee ("**Secured Party**"), a true and correct copy of which was recorded by the United States Patent and Trademark Office against one of the Trademarks on November 9, 2000, at Reel 002172, Frame 0122. It was recorded separately against the other three Trademarks as well as against other trademarks listed in Schedule 1 (the latter are "**Other Trademarks**") to the Security Agreement;

WHEREAS, the Secured Party desires to release its security interest in the Trademarks and the Other Trademarks and terminate the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, receipt of which is acknowledged, Secured Party releases and reassigns to the Grantor any and all liens, security interests, right, title and interest of Secured Party pursuant to the Security Agreement in the Trademarks and any of the Other Trademarks which Grantor owns, without recourse or representation or warranty, express or implied. The Secured Party confirms that the Security Agreement is no longer effective as to the Trademarks and the Other Trademarks and that it has no right to or claims against the Trademarks and the Other Trademarks.

The parties request the Commissioner of Patents and Trademarks of the United States of America to record this release.
