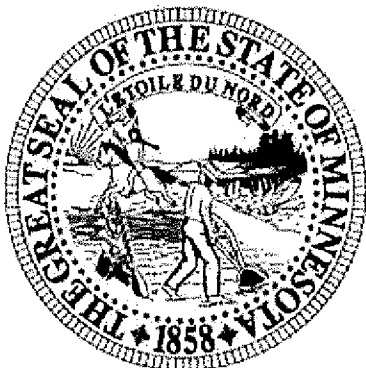

ARTICLES OF MERGER
of
ADVANCED URO-SOLUTIONS, LLC
(a Tennessee limited liability company)
into
MEDTRONIC, INC.
(a Minnesota corporation)

Pursuant to the provisions of section 302A.621 of the Minnesota Business Corporation Act, the merger of a foreign wholly-owned subsidiary limited liability company into its domestic parent corporation, hereinafter named does hereby adopt the following Articles of Merger.

- FIRST. The following is the Plan of Merger for merging Advanced Uro-Solutions, LLC into Medtronic, Inc. as set forth in a resolution approved by the affirmative vote of a majority of the Board of Directors of Medtronic, Inc. and the Sole Member under the provisions of Section 302A.621 of the Minnesota Business Corporation Act.
- SECOND. The name of the non-surviving subsidiary limited liability company, organized under the laws of the State of Tennessee is Advanced Uro-Solutions, LLC. The name of the surviving parent corporation, organized under the laws of the State of Minnesota is Medtronic, Inc.
- THIRD Medtronic, Inc., owns directly all outstanding membership interest in Advanced Uro-Solutions, LLC.
- FOURTH The laws of the jurisdiction of organization of Advanced Uro-Solutions, LLC permit the merger of a limited liability company of that jurisdiction with and into a corporation of another jurisdiction; and the merger of Advanced Uro-Solutions, LLC with and into Medtronic, Inc. is in compliance with the laws of the jurisdiction of organization of Advanced Uro-Solutions, LLC.
- FIFTH The merger of Advanced Uro-Solutions, LLC into Medtronic, Inc. shall become effective in the State of Minnesota on the 24th day of November 2020.

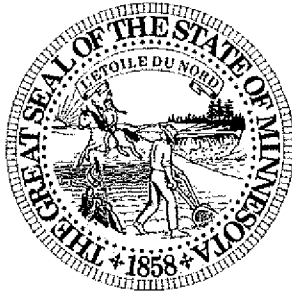
