If and to the extent that Agent has acquired any right, title or interest in or to any of the Trademark Collateral, it hereby assigns and transfers such rights, title or interest to Company, along with (1) all proceeds and products of such Trademark Collateral, (2) the goodwill associated with such Trademark Collateral and (3) all causes of action arising prior to or after the date hereof for infringement of such Trademark Collateral or unfair competition regarding the same, and any and all other rights, title and interest in and to such Trademark Collateral and related rights that any goodwill in the Trademarks that the Agent may have acquired.




