**RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of February 17, 2021, is made by COMVEST CAPITAL IV, L.P., in its capacity as Agent for the Secured Persons (in such capacity, together with its successors, the “Agent”), under that certain Trademark Security Agreement, dated as of April 26, 2018, recorded in the Trademark Assignment database of the United States Patent and Trademark Office on April 30, 2018 at Reel 6346/Frame 0075 (as amended, restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”) by and among Acima Credit, LLC, a Utah limited liability company (the “Grantor”), and the Agent. Terms used in this Release and not herein defined shall have the meanings set forth in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement, the Grantor granted to Agent, for the benefit of the Secured Persons, a security interest in certain trademarks set forth in Annex I attached hereto (the “Trademarks”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby: (i) terminates, cancels, releases and discharges, without representation, recourse or warranty whatsoever, all of its security interest in and to all of its right, title and interest in the Trademarks (including all goodwill of the business connected with the use of, and symbolized by, the Trademarks), granted pursuant to the Trademark Security Agreement, (ii) retransfers and reassigns any and all such right, title and interest (if any) that Agent may have in the Trademarks to the Grantor and (iii) agrees to duly execute, acknowledge, procure and deliver any further documents and take any further action as may be reasonably necessary to effect the intent and purpose of this Release, which shall be at the Grantor’s sole cost and expense.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York without giving effect to the conflict of law principles thereof except for Sections 5-1401 and 5-1402 of the New York General Obligations Law.




