Assignor authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office to record this Trademark Assignment in favor of Assignee, as assignee of Assignor's entire right, title, and interest in the Trademark. Assignor agrees to execute any other documents reasonably necessary to affect this Trademark Assignment or to confirm Assignee's ownership of the Trademark.

This Trademark Assignment may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all such counterparts taken together shall constitute one and the same instrument.
