The assignment of the Trademarks granted herein includes an assignment and transfer of all goodwill associated therewith.
2. All of the terms and provisions of this Assignment are binding upon Assignor, Assignee and their respective successors and assigns and will inure to the benefit of the other parties and its respective successors and assigns.
3. Each party hereby agrees to execute and deliver any and all additional documents that any other party may reasonably request and to use commercially reasonable efforts to take such further actions as may be reasonably necessary, to effectuate, carry out, and comply with the agreements set forth in this Assignment.
4. This Assignment may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original but all such counterparts together shall constitute one and the same instrument. This Assignment may be executed by facsimile or portable document formation (.pdf), which shall be deemed and original in all cases.

IN WITNESS WHEREOF, each of the parties has caused this Assignment to be executed in its name and delivered by a duly authorized officer, on the date written below.


