RELEASE OF TRADEMARK SECURITY INTERESTS

THIS RELEASE OF TRADEMARK SECURITY INTERESTS (this “Release”), dated this 22nd day of February, 2021, is by BMO HARRIS BANK N.A., as administrative agent (in such capacity, the “Administrative Agent”) for the Lenders and other Secured Creditors (as defined in the Security Agreement described below), with its mailing address at 310 West Walnut Street, Green Bay, Wisconsin 54303 to NPS OF WI, LLC, a Wisconsin limited liability company, formerly known as “National Tissue Company LLC” (the “Grantor”). Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Security Agreement (as defined below).

A. WHEREAS, the Grantor granted the Administrative Agent a Lien on and continuing security interest in the Trademark Collateral, including those trademarks listed on Exhibit A attached hereto pursuant to a Trademark Security Agreement dated January 31, 2014 (the “Security Agreement”);

B. WHEREAS, the Administrative Agent recorded its interest in the Trademark Collateral with the United States Patent and Trademark Office (the “USPTO”) on February 1, 2014, in Reel 5206 Frame 0055; and

C. WHEREAS, the Grantor requests that the Administrative Agent release any and all right, title, and interest in and to the Trademark Collateral, and the Administrative Agent agrees to release any and all such right, title, and interest.

NOW, THEREFORE, FOR VALUE RECEIVED, the Administrative Agent agrees as follows:

1) The Administrative Agent does hereby terminate the Security Agreement and terminate and release its Lien on and security interest in and to the Trademark Collateral, including those trademarks listed on Exhibit A. The Administrative Agent does hereby assign, grant and convey to the Grantor, without any representation, warranty, recourse or undertaking by the Administrative Agent, any and all of the Administrative Agent’s right, title, and interest in and to the Trademark Collateral, including those trademarks listed on Exhibit A.

2) The Administrative Agent hereby authorizes the Grantor (or its authorized representative) to file copies of this Release with the USPTO, and any other document with any other filing office necessary to memorialize this Release and to extinguish the Administrative Agent’s rights and interest in the Trademark Collateral.


3) This Release is governed by the laws of the State of Wisconsin without regard to the principles of conflicts of laws.
