Trademark Assignment

This Trademark Assignment is made and entered into as of November 1, 2020 by and between Beau Gunn, an individual, ("Assignor") to Live Nation Worldwide, Inc., a Delaware corporation, ("Assignee").

NOW THEREFORE for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignor does hereby irrevocably sell, assign, set over and transfer to Assignee All Rights in the Mark. The rights of Assignee at common law and/or to the end of the term or terms for which registration of the Mark may be granted or renewed are to be held and enjoyed by Assignee for Assignee's own use and enjoyment, and for the use and enjoyment of its successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Trademark Assignment had not been made.
2. This Trademark Assignment shall be binding upon and inure to the benefit of the parties named herein and their respective successors and permitted assigns. No party may assign either this Trademark Assignment or any of its rights, interests, or obligations hereunder without the prior written approval of the parties.
3. From time to time after the date hereof, the Assignor and Assignee agree to promptly take such further actions and execute and deliver such additional instruments of contribution, transfer, assignment, conveyance, delivery and assumption, and such consents, assurance and other similar instruments as may be reasonably requested by the other party in order to vest in Assignee all right, title and interest in and to the Mark and to carry out the purpose and intent of this Agreement.


