INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement (this “**Agreement**”) is entered into as of February 22, 2021 by and among **RENVENT GP, LLC**, a Texas limited liability company (“**Lender**”) and **VENUETIZE, INC.**, a Delaware corporation (“**Borrower**”).

RECITALS

WHEREAS, Lender has provided certain loans to Borrower pursuant to that certain Loan and Security Agreement of even date herewith (as amended, supplemented or otherwise modified from time to time, the “**Loan Agreement**”), by and between Borrower and Lender;

WHEREAS, pursuant to the terms of the Loan Agreement, Borrower has granted to Lender a security interest in their personal property constituting Collateral; and

WHEREAS, the capitalized terms used but not defined herein shall have the meanings ascribed to them in the Loan Agreement.

NOW, THEREFORE, Borrower and Lender agree as follows:

AGREEMENT

To secure the Obligations, Borrower hereby grants to Lender a security interest in all of Borrower’s right, title and interest in its Intellectual Property (including without limitation those Copyrights, Patents and Trademarks listed on Exhibit A hereto) and all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof; in each case, except to the extent constituting Excluded Property.

Borrower represents and warrants that Exhibit A hereto sets forth any and all Intellectual Property rights in connection to which Borrower has registered or filed an application with either the United States Patent and Trademark Office or the United States Copyright Office. This Agreement may be executed in two or more counterparts, each of which shall be deemed an original but all of which together shall constitute the same instrument.


