**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
UNITED PROPANE GAS COMPANIES, INC.**

Pursuant to the provisions of KRS 271B.010-060, the following Articles of Amendment to the Articles of Incorporation of United Propane Gas Companies, Inc., a Kentucky corporation (the "Corporation"), are hereby adopted:

**FIRST:** The name of the Corporation is United Propane Gas Companies, Inc.

**SECOND:** Article I of the Articles of Incorporation of the Corporation shall be amended to read in its entirety as follows:

**ARTICLE I**

The name of the Corporation is United Propane Gas, Inc.

**THIRD:** The amendments were recommended by the board of directors and adopted by the shareholders of the Corporation pursuant to unanimous written consent, in lieu of a meeting, in accordance with KRS 271B.7-040 on February 28, 2003.

**FOURTH:** The designation, number of outstanding shares, number of votes entitled to be cast by each voting group entitled to vote separately on the amendments, and number of votes of each group indisputably cast pursuant to unanimous written consent in lieu of a meeting were as follows:

Designation of Voting Group:	Common Stock
Number of Outstanding Shares:	500
Number of Votes Entitled to be Cast:	500
Number of Votes Indisputably Cast Pursuant to Unanimous Written Consent In Lieu of a Meeting:	500

The total number of undisputed votes cast by unanimous written consent for the amendment by holders of Common Stock of the Corporation, being the sole voting group entitled to vote thereon, was 100, which was sufficient for approval by that voting group.
