TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Termination and Release of Security Interest in Trademarks is hereby entered into as of January 8, 2021 by and between Silicon Valley Bank, a California corporation having a business address at 75 Grove Street, Suite 2-200, Newton, Massachusetts 02466 ("Bank"), and RapidMiner, Inc., a Delaware corporation having a principal place of business at One Boston Place, Suite 2600, Boston, Massachusetts 02108 ("RapidMiner").

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated March 10, 2016 by and between Bank and RapidMiner, and recorded with the U.S. Patent and Trademark Office at Reel 5749, Frame 0710, RapidMiner granted to Bank a security interest in all its intellectual property (the "Intellectual Property Collateral"), including without limitation two United States trademark registrations Nos. 4,926,755 and 4,926,757 for the trademarks RAPIDMINER and RAPIDMINER [& design] (respectively) as set forth in detail in the attached Exhibits;

WHEREAS, the Intellectual Property Security Agreement was terminated on or about November 27, 2017;

NOW, THEREFORE, the parties wish to memorialize the termination of the Intellectual Property Security Agreement and the release of all security interests granted therein.

1. Bank does hereby terminate, release and set over to RapidMiner any and all security interest it has, may have, or ever had in and to the Intellectual Property Collateral, free and clear of all claims, liens or encumbrances.

2. Bank further authorizes RapidMiner to record this document with the United States Copyright Office, the United States Patent & Trademark Office, and/or any other U.S. state or foreign authority or agency, whose duty it is to record patent, trademark and/or copyright registrations, applications and title thereto, to record the Intellectual Property Collateral and title thereto as the property of RapidMiner, its successors, legal representatives and assigns in accordance with the terms of this instrument.
