INTELLECTUAL PROPERTY ASSIGNMENT

This Intellectual Property Assignment (this "Assignment") dated as of December 18, 2020, by and between Smith Micro Software, Inc., a Delaware corporation ("Seller"), in favor of Lost Marble LLC, a California limited liability company ("Buyer"), is entered into pursuant to that certain Asset Purchase Agreement dated as of December 17, 2020, between Seller and Buyer (the "Purchase Agreement"). Seller and Buyer are sometimes individually referred to as a "Party" and collectively as the "Parties."

The Parties, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, agree as follows:

1. Definitions. Unless otherwise defined herein, all capitalized terms used herein shall have the definitions given such terms in the Purchase Agreement.

2. Conveyance and Assignment. Seller hereby conveys, transfers, assigns, sells and delivers to Buyer, its successors and assigns, all of Seller's right, title and interest in and to the Seller Registered Intellectual Property Rights described in Exhibit A attached hereto and all related goodwill.

3. Terms of the Purchase Agreement. The terms of the Purchase Agreement, including, but not limited to, (i) the Parties' representations, warranties, covenants, agreements and indemnities relating to the Purchased Assets, and (ii) matters of applicable law, venue, dispute resolution, and all other general provisions, are incorporated herein by this reference.

4. Counterparts; Facsimile. This Assignment may be executed in two or more counterparts, each of which shall be deemed to be an original but all of which shall constitute one and the same agreement. Signatures of the Parties transmitted by facsimile or .pdf format via electronic mail shall be deemed to be their original signatures for all purposes.

5. Binding Effect. This Assignment shall be binding upon the Parties hereto and their respective heirs, legal representatives, successors, and assigns.

6. Registration. This Assignment may be recorded with the United States Patent and Trademark Office or with any other appropriate office of any other jurisdiction to evidence the assignment of the Seller Registered Intellectual Property.
