Pursuant to Section 264(c) of the General Corporation Law of the State of Delaware (the "DGCL") and Section 18-209 of the Limited Liability Company Act of the State of Delaware (the "Act"), Drunk Elephant Blocker, Inc., a Delaware corporation (the "Company"), in connection with the merger of Drunk Elephant Holdings, LLC, a Delaware limited liability company, with and into the Company (the "Merger"), hereby certifies as follows:

FIRST: The names and states of formation or incorporation of the constituent entities to the Merger (the "Constituent Entities") are as follows:
