TRADEMARK ASSIGNMENT

This trademark assignment ("Assignment") is made effective as of February 24, 2021 ("Effective Date"), by and between Dominion Enterprises, a Virginia partnership composed of Dominion Enterprises Group, LLC, a Nevada limited liability company, and LTM Company Dominion, LLC, a Virginia limited liability company, and having a principal office at 150 Granby Street, Norfolk, Virginia 23510 ("Assignor"), and Homes.com, Inc., a Delaware corporation having a principal office at 150 Granby Street, Norfolk, Virginia 23510 ("Assignee").

NOW, THEREFORE, in return for good and valuable consideration exchanged between Assignor and Assignee, the receipt and adequacy of each of them acknowledges, Assignor and Assignee do hereby agree as follows:

1. Assignment. Assignor hereby irrevocably assigns to Assignee any and all of Assignor's right, title, and interest in and to the Assigned Property, including without limitation all USPTO and U.S. state registration, maintenance, and renewal rights with respect to the Assigned Property; all rights to create new marks based on the Assigned Property; that certain business, including without limitation all of the goodwill associated with the business and with the Mark, that deals in any or all of the goods and/or services with which the Assigned Property has been used, is used, or is intended to be used, in association therewith; any and all actions and rights of action for infringement, violation, or misappropriation, including without limitation the right to sue and collect damages for past infringement, of the foregoing right, title, and interest in and to the Assigned Property and/or otherwise with respect to the Assigned Property, whether arising before, on, or after the Effective Date; and any and all other rights arising from or associated with the Assigned Property.




