**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
GORDON & DONER, P.A.**

Pursuant to the provisions of Section 607.1006, Florida Statutes, Gordon & Doner, P.A., a Florida for profit corporation (the "Corporation"), Document No. P92000005145, adopts the following amendments to its Articles of Incorporation:

1. The new name of the Corporation shall be Gordon & Partners, P.A.
2. The officers of the Corporation shall be amended as follows:
 - a. Adam S. Doner shall be removed as Treasurer and Secretary
 - b. Steven G. Calamusa shall be added as Treasurer
 - c. Daniel G. Williams shall be added as Secretary
3. The amendment was adopted by the directors and the shareholders of the Corporation on September 30, 2018. The number of votes cast for the amendment by the shareholders was sufficient for approval.
