TERMINATION AND RELEASE OF LIEN IN INTELLECTUAL PROPERTY

THIS TERMINATION AND RELEASE OF LIEN IN INTELLECTUAL PROPERTY (this “Release”), is dated as of February 24, 2021, and made by Siena Lending Group LLC (“Lender”) in its capacity as Lender under the below-defined Security Agreement, in favor of Specialty Bakers LLC, a Delaware limited liability company (“Grantor”).

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of March 1, 2019 made by Grantor in favor of Lender (as amended, supplemented, amended and restated or otherwise modified from time to time, the “Security Agreement”), a security interest was granted by Grantor to Lender in certain collateral, including the Specified IP Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office (the “USPTO”) on March 1, 2019, at Reel 6578 and Frame 0553;

WHEREAS, Lender now desires to terminate and release its security interest in the Specified IP Collateral defined below;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, Lender hereby states as follows:


1. Definitions. The term “Specified IP Collateral,” as used herein, means all of Grantor’s right, title and interest in Grantor’s intellectual property, including, without limitation, that which is listed on Schedule A hereto.


2. Release of Security Interest. Lender hereby terminates, releases and discharges its security interest in the Specified IP Collateral and reassigns to the person or persons legally entitled thereto all of its right, title and interest in the Specified IP Collateral. Lender acknowledges that this Release may be filed with the USPTO or any other governmental office to evidence the termination and release granted by this Release.
