INTELLECTUAL PROPERTY ASSIGNMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT is effective, *nunc pro tunc*, as of June 18, 2012 (the "Effective Date"), by and between Dadanco-Mestek Joint Venture LLC, a Delaware limited liability company ("Assignor"), and Mestek, Inc., a Pennsylvania corporation ("Assignee").

WHEREAS, Assignor is a Joint Venture LLC created between Assignee and Dadanco US, Inc., a Delaware corporation ("Dadanco"), with Assignee and Dadanco each owning a 50% interest in Assignor;

WHEREAS, pursuant to the Membership Interests Purchase Agreement dated June 18, 2012 (the "Purchase Agreement"), between Dadanco and Assignee, Assignee purchased Dadanco's entire interest in Assignor and became the sole owner of Assignor;


WHEREAS, Assignor is desirous of assigning all right, title and interest in its trademarks, patents, copyrights, trade secrets, know-how, and other intellectual property, including U.S. Trademark Registration No. 3,948,079 for the mark ACB (hereafter, the "Mark") (all of the foregoing, collectively, the "Intellectual Property"), and all associated common law rights in, goodwill under, and registrations for, the Intellectual Property, to the Assignee; and


WHEREAS, Assignee is desirous of acquiring all right, title and interest in and to Intellectual Property, including all associated common law rights in, goodwill under, and registrations for, such Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee all right, title and interest in and to the Intellectual Property as of the Effective Date, including all associated common law rights in, goodwill under, and registrations for, such Intellectual Property, including without limitation the right to sue and collect damages for past, present and future infringements of the Intellectual Property, and to further assign or to license any and all right, title and interest in and to the Intellectual Property.
