RELEASE OF FIRST LIEN TRADEMARK SECURITY AGREEMENT

This RELEASE OF FIRST LIEN TRADEMARK SECURITY AGREEMENT (this "Release"), dated as of February 26, 2021, is made by Credit Suisse AG, Cayman Islands Branch as Administrative Agent (in such capacity, the "Administrative Agent") for the benefit of the Secured Parties, in favor of Emergency Consultants, LLC, Emergency Consultants PSO, LLC, Hospitalist Consultants, LLC and ECI Healthcare Partners, LLC (each a "Grantor," and collectively the "Grantors"). WHEREAS, pursuant to the terms and conditions of the First Lien Pledge and Security Agreement and the Trademark Security Agreement, each Grantor granted to the Administrative Agent, on behalf of and for the ratable benefit of the Secured Parties, a security interest (the "Security Interest") in the following: all of such Grantor's right, title and interest in, to and under the Trademark Collateral, including the registrations and applications of such Grantor set forth on Schedule 1 (the "Released Collateral"); and

WHEREAS, the Administrative Agent desires to terminate and release the Security Interest in the Released Collateral.

Each Grantor, or any successor to such Grantor (including any person or entity hereafter having any right, title or interest in or to the Released Collateral of such Grantor), is hereby authorized to record this Release in the United States Patent and Trademark Office.
