ARTICLES OF AMENDMENT

TO THE

AMENDED AND RESTATED ARTICLES OF ASSOCIATION OF

CENTERSTATE BANK, N.A.

Pursuant to 12 U.S.C. Section 21a, the Amended and Restated Articles of Association of CenterState Bank, N.A., are hereby amended as follows:

1. Article FIRST of the Amended and Restated Articles of Association is hereby amended by deleting the text thereof in its entirety and substitute the following sentence in lieu thereof:

“FIRST. The title of this association shall be South State Bank, National Association.”

2. The foregoing amendment was approved by the sole shareholder of CenterState Bank, N.A., by the action of the sole shareholder, dated June 4, 2020 as required by 12 U.S.C. Section 21a.

3. The foregoing amendment shall be effective as of June 8, 2020 at 12:01 am EST.


