**RELEASE OF SECOND LIEN TRADEMARK SECURITY AGREEMENT**

This **RELEASE OF SECOND LIEN TRADEMARK SECURITY AGREEMENT** (this “Release”), dated as of February 26, 2021, is made by Credit Suisse AG, Cayman Islands Branch as Administrative Agent (in such capacity, the “Administrative Agent”) for the benefit of the Secured Parties, in favor of BCH, Inc., MyPoint, Inc., The Schumacher Group of Delaware, Inc., and Subsidiary Healthcare, LLC (each a “Grantor,” and collectively the “Grantors”). Capitalized terms not otherwise defined herein have the meanings set forth, directly or by reference, in the Trademark Security Agreement (as defined below).

**WHEREAS**, the Grantors and the Administrative Agent entered into that certain Second Lien Pledge and Security Agreement dated as of July 31, 2015, (the “Second Lien Pledge and Security Agreement”), pursuant to which the Grantors executed and delivered to the Administrative Agent that certain Second Lien Trademark Security Agreement, dated as of July 31, 2015 (the “Trademark Security Agreement”), which was recorded in the United States Patent and Trademark Office on October 2, 2015 at Reel/Frame 5636/0876 (with respect to BCH, Inc.), at Reel/Frame 5636/0884 (with respect to MyPoint, Inc.), at Reel/Frame 5636/0851 (with respect to The Schumacher Group of Delaware, Inc.), and at Reel/Frame 5636/0892 (with respect to Subsidiary Healthcare, LLC);

**WHEREAS**, pursuant to the terms and conditions of the Second Lien Pledge and Security Agreement and the Trademark Security Agreement, each Grantor granted to the Administrative Agent, on behalf of and for the ratable benefit of the Secured Parties, a security interest (the “Security Interest”) in the following: all of such Grantor’s right, title and interest in, to and under the Trademark Collateral, including the registrations and applications of such Grantor set forth on Schedule 1 (the “Released Collateral”); and

**WHEREAS**, the Administrative Agent desires to terminate and release the Security Interest in the Released Collateral.


**NOW, THEREFORE**, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent on behalf of the Secured Parties, hereby terminates, releases and forever discharges the Trademark Security Agreement and the Security Interest in the Released Collateral, and retransfers and reassigns to each Grantor any right, title or interest the Administrative Agent may have in, to or under such Grantor’s Released Collateral, in each case without recourse to the Administrative Agent, and without representation or warranty of any kind.






