INTELLECTUAL PROPERTY ASSIGNMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT (this “**Assignment**”), effective as of March 1, 2021, is entered into by and between CyberScout, LLC, a Delaware limited liability company, CyberScout Claims, LLC, a Delaware limited liability company (together, the “**Sellers**”), and Sontiq, Inc., a Delaware corporation (“**Purchaser**”) (together, the “**Parties**”), pursuant to Section 2.1(e) of the Asset Purchase Agreement, dated January 29, 2021, by and between Sellers, Purchaser, and the other parties thereto (the “**Purchase Agreement**”).

All capitalized terms used but not otherwise defined herein shall have the meanings ascribed to them in the Purchase Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and agreements of the parties as hereinafter set forth and other good and valuable consideration, the receipt and sufficiency of which hereby are acknowledged, the parties hereto hereby agree as follows:

1. Assignment. In conjunction with the Assignment and Assumption Agreement and Assignment of Contracts between the Parties executed as of the date hereof, Sellers hereby assign and transfer to Purchaser all rights, title and interest of Sellers throughout the world and in perpetuity, including all statutory and common law rights, in and to the Intellectual Property Rights, together with all goodwill symbolized thereby and/or associated therewith, and the right to sue or make claims for any past, present or future infringement, misappropriation or unauthorized use thereof and the right to all income, royalties, damages and other payments that are now or may hereafter become due or payable with respect thereto, including, without limitation, damages for any past, present or future infringement, misappropriation or unauthorized use of the Intellectual Property Rights; all of such rights, title and interest to be held and enjoyed by Purchaser and its successors and assigns to the same extent that such would have been held and enjoyed by Sellers had this Assignment not been made. For the avoidance of doubt, the Intellectual Property Rights shall specifically include, without limitation, all of the assets specified in Exhibit A attached hereto and shall specifically exclude, without limitation, all of the assets specified in Exhibit B attached hereto.

2. Further Assurance. Sellers agree to execute, deliver and file (or cause to be executed, delivered and filed) such further documentation and take such further action as may be reasonably requested by Purchaser in order to fully effectuate the above assignment of rights with respect to the Intellectual Property Rights.

3. Terms of the Purchase Agreement. Nothing contained in this Agreement will be deemed to alter, diminish or expand in any manner whatsoever any of the provisions of, or any of the rights and obligations of the Parties under, the Purchase Agreement, and this Agreement is subject to all of the terms, conditions and limitations set forth in the Purchase Agreement. Nothing in this Agreement is intended to create any broader obligations of the Parties than those contemplated in the Purchase Agreement or shall be deemed to release either the Sellers or the Purchaser in any way from any of their respective obligations under the Purchase Agreement other than those performed by this Agreement. In the event of any conflict between the Purchase Agreement and this Agreement, the Purchase Agreement will control.

4. Entire Agreement. This Assignment, together with the Purchase Agreement, constitute the entire agreement and supersede all prior agreements and understandings, written and oral, between the parties hereto with respect to the subject matter hereof.

5. Governing Law. This Assignment shall be governed by and construed in accordance with the federal laws of the United States (where applicable) and the laws of the State of Delaware (without giving effect to the conflict of laws provisions thereof).

6. Consent to Jurisdiction. The Parties hereby agree that the United States federal courts located in the State of Delaware shall have exclusive jurisdiction over the resolution of any dispute under this Assignment or regarding the transactions contemplated hereby, and submit and consent to the personal jurisdiction of such courts and that venue is proper therein; provided, however, that if United States federal courts located in Delaware lack subject matter jurisdiction over any dispute hereunder, the Parties hereby agree that the state courts of Delaware shall have exclusive jurisdiction over the resolution of any such dispute and the Parties hereby agree to the personal jurisdiction of such courts and that venue is proper therein.

7. Waiver of Jury Trial. Each of the Parties hereto hereby waives, to the fullest extent permitted by applicable law, any right to a trial by jury in any action or proceeding to enforce or defend any rights under this Assignment or any document entered into with this Assignment and any amendment, instrument, document or agreement delivered or which may in the future be delivered in connection herewith or therewith, and agrees that any such action or proceeding shall be tried before a court and not before a jury.

8. Counterparts. This Assignment may be executed in any number of counterparts, each of which when so executed shall constitute an original copy hereof, but all of which together shall constitute one agreement. The Parties hereto agree that the delivery of this Assignment by facsimile or e-mailed .pdf files of scanned copies bearing their respective signatures shall be sufficient and binding upon them as if such document were delivered with original signatures.


