
ARTICLES OF DOMESTICATION OF

The undersigned, on behalf of the foreign limited liability company set forth below, pursuant to Title 13.1, Chapter 12, Article 14 of the Code of Virginia, states as follows:

1. The name of the limited liability company immediately prior to the filing of these articles of domestication is Vudu, LLC. Upon the filing of these articles, the name of the limited liability company shall be Vudu, LLC.
2. The limited liability company was originally incorporated under the laws of Delaware on April 27, 2005 as a corporation with the name Vudu, Inc.
3. Vudu, Inc., a Delaware corporation, was converted to Vudu, LLC, a Delaware limited liability company on June 30, 2020.
4. The plan of domestication, pursuant to § 13.1-1075 of the Code of Virginia, is set forth as follows:
 - A. The limited liability company is presently domesticated under the laws of the State of Delaware, and the jurisdiction in which the limited liability company is to be domesticated is the Commonwealth of Virginia.
 - B. The full text of the articles of organization that will be in effect immediately after consummation of the domestication is attached hereto.
