**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

THIS NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Release”) is made as of March 2, 2021, by PNC BANK, NATIONAL ASSOCIATION, in its capacities as administrative agent and collateral agent (together with its successors and assigns, the “Administrative Agent”), in favor of SYSTEM ONE HOLDINGS, LLC (together with its successors and assigns, the “Grantor”).

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of October 31, 2016 (the “Agreement”) by the Grantor in favor of Administrative Agent, and recorded in the United States Patent and Trademark Office on November 1, 2016, at Reel/Frame 5912/0108, the Grantor granted to Administrative Agent, for the benefit of the Secured Parties (as defined in the Agreement), a lien on and security interest in all right, title and interest of the Grantor in, to and under the trademark registrations and applications listed on Schedule A hereto together with the goodwill of the business symbolized by such trademark registrations and applications.

WHEREAS, Administrative Agent wishes to terminate, release, relinquishment and discharge its liens on and security interest in any Trademarks included in the Collateral, as those terms are defined in the Agreement.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, Administrative Agent hereby terminates, cancels, relinquishes, releases and discharges all liens and security interest in any Trademarks included in the Collateral, including without limitation the Trademarks listed on Schedule A and transfers and conveys to Grantor any interest in the foregoing.


Administrative Agent hereby authorizes and requests that the United States Patent and Trademark Office and any other applicable government officer record this Release.

THIS RELEASE SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
