**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) dated as of January 26, 2021 (this “Release”), is made by Citizens Bank, N.A., as administrative agent (“Agent”), in favor of Mohegan Tribal Gaming Authority (“Borrower”), a governmental instrumentality of The Mohegan Tribe of Indians of Connecticut, a federally recognized Indian Tribe and Native American sovereign nation (the “Tribe”), and Downs Racing, L.P., a Pennsylvania limited partnership (“Downs Racing”, and together with Borrower, each a “Grantor” and collectively the “Grantors”). Capitalized Terms not defined herein shall have the meanings attributed to them in the Credit Agreement, Security Agreement and IP Security Agreement (as defined below).

**WHEREAS**, the Grantors, Borrower, the Agent, and other parties thereto, entered into that certain Credit Agreement, dated as of October 14, 2016 (as amended by that certain First Amendment to Credit Agreement, dated as of April 14, 2017, that certain Incremental Joinder and Second Amendment to Credit Agreement, dated as of April 12, 2018, that certain Third Amendment to Credit Agreement, dated as of August 13, 2020, that certain Fourth Amendment to Credit Agreement, dated as of August 28, 2020, and as further amended, restated, amended and restated, supplemented or otherwise modified from time to time prior to the date hereof, the “Credit Agreement”), pursuant to which each Grantor executed and delivered to the Agent (i) that certain Security Agreement, dated as of October 14, 2016 (the “Security Agreement”) and (ii) that certain Intellectual Property Security Agreement, dated as of October 14, 2016 (the “IP Security Agreement”, together with the Credit Agreement and Security Agreement, the “Security Documents”);

**WHEREAS**, the IP Security Agreement was recorded with the United States Patent and Trademark Office on October 14, 2016 at Reel/Frame 5900/0204 and 5900/0232;

**WHEREAS**, pursuant to the Security Documents, each Grantor pledged, collaterally assigned, mortgaged, transferred and granted to the Agent, on behalf of and for the ratable benefit of the Secured Parties, a continuing security interest (the “Security Interest”) in all of the Grantors’ right, title or interest in, to or under all of the following assets, whether then owned or at any time thereafter acquired by or arising in favor of each Grantor and regardless of where located: (a) all Trademarks, including, those Trademark registrations and pending applications in the United States Trademark and Trademark Office listed on Schedule I hereto; (b) the right to sue third parties for past, present and future infringements of any Trademark; and (c) all proceeds of any and all right associated with the foregoing; in each case to the extent the foregoing items constitute Collateral (the “Trademark Collateral”); and


**WHEREAS**, pursuant to the Payoff Letter dated as of January 26, 2021, among the Borrower, the other Loan Parties thereto and the Agent, the Agent agreed to terminate and release the entirety of its Security Interest in the Trademark Collateral pursuant to the Security Documents.

**NOW, THEREFORE**, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent on behalf of the Secured Parties, hereby terminates, releases, relinquishes and forever discharges the Security Interest in the Trademark Collateral, and retransfers and reassigns to each Grantor any right, title or interest the Agent may have in, to or under the Trademark Collateral. The Agent agrees to make filings with the United States Patent and Trademark Office and other necessary filings, in each case, reasonably requested by the Borrower to evidence release and termination of the Agent’s Security Interests in the Trademark Collateral.


