## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this “Release”) is made as of January 28, 2021 (the “Effective Date”) by BMO Harris Bank N.A. (the “Administrative Agent”), in favor of Riddell, Inc. (“Riddell”) and MacMark Corporation (“MacMark”; MacMark together with Riddell, individually and collectively, “Grantor”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Credit Agreement or the Trademark Security Agreement (as defined below), as applicable.

**WHEREAS**, Grantor, the Administrative Agent, and the other parties thereto entered into that certain Credit Agreement, dated as of June 15, 2018 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), which required the parties to enter into the Trademark Security Agreement (defined below);

**WHEREAS**, Riddell and the Administrative Agent entered into that certain Grant of a Security Interest - Trademarks dated June 15, 2018 (the “2018 Riddell Trademark Security Agreement”), under which Riddell mortgaged, pledged and hypothecated to the Administrative Agent for the benefit of the Lenders, and granted to the Administrative Agent for the benefit of the Lenders a Lien on and security interest in, all of its right, title and interest in, to and under its Trademarks and applications therefor listed on Schedule 1 hereto; and such Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 15, 2018, at Reel 6354, Frame 0129;

**WHEREAS**, MacMark and the Administrative Agent entered into that certain Grant of a Security Interest - Trademarks dated June 15, 2018 (the “2018 MacMark Trademark Security Agreement”), under which MacMark mortgaged, pledged and hypothecated to the Administrative Agent for the benefit of the Lenders, and granted to the Administrative Agent for the benefit of the Lenders a Lien on and security interest in, all of its right, title and interest in, to and under its Trademarks and applications therefor listed on Schedule 1 hereto; and such Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 15, 2018, at Reel 6354, Frame 0291;

**WHEREAS**, Riddell and the Administrative Agent entered into that certain Grant of a Security Interest - Trademarks dated September 24, 2020 (the “2020 Trademark Security Agreement” together with the 2018 Riddell Trademark Security Agreement and the 2018 MacMark Trademark Security Agreement, the “Trademark Security Agreement”), under which Riddell mortgaged, pledged and hypothecated to the Administrative Agent for the benefit of the Lenders, and granted to the Administrative Agent for the benefit of the Lenders a Lien on and security interest in, all of its right, title and interest in, to and under its Trademarks and applications therefor listed on Schedule 1 hereto; and such Trademark Security Agreement was recorded with the United States Patent and Trademark Office on September 25, 2020, at Reel 7061, Frame 0520;

**WHEREAS**, Grantor has satisfied the terms of the Trademark Security Agreement and requests a specific release of the security interest granted and recorded against the Trademark Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby, on behalf of itself and the Secured Parties, (i) terminates the Trademark Security Agreement, (ii) releases any

and all liens, security interests, right, title and interest the Administrative Agent or any Secured Party may have in, to or under the Trademark Collateral, (iii) re-assigns to Grantor, any right, title or interest the Administrative Agent or any Secured Party may have in, to or under the Trademark Collateral and (iv) hereby authorizes the Grantor or the Grantor's authorized representative or designee to record this Release with the United States Patent and Trademark Office as evidence of such release and termination

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of Illinois.

**IN WITNESS WHEREOF**, the Administrative Agent has caused this Release to be executed, on behalf of itself and the Lenders, by its duly authorized representative effective as of the Effective Date.
