RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of March 4, 2021 (this “Release”), is made by ANTARES CAPITAL LP, as administrative agent for certain lenders (the “Administrative Agent”), in favor of SMARTBEAR SOFTWARE INC., a Delaware corporation (the “Grantor”).

W I T N E S S E T H

WHEREAS, the Grantor, the Administrative Agent, and the other parties thereto from time to time, are parties to that certain First Lien Security Agreement, dated as of May 24, 2017 (as amended, restated, amended and restated, supplemented, extended, refinanced or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, the Grantor executed the (i) Memorandum of Security Interest in Trademarks, dated as of May 24, 2017 (the “2017 Trademark Security Agreement”) and recorded with the U.S. Patent and Trademark Office (“USPTO”) on May 25, 2017 at Reel/Frame No. 6068/0879 and (ii) Memorandum of Security Interest in Trademarks, dated as of October 1, 2018 (the “2018 Trademark Security Agreement” and together with the 2017 Trademark Security Agreement, the “Trademark Security Agreements”) and recorded with the USPTO on October 1, 2018 at Reel/Frame No. 6446/0440, pursuant to which the Grantor granted to the Administrative Agent a first lien security interest in the Trademarks (as defined in the Security Agreement).

WHEREAS, the Grantor has paid all of its outstanding indebtedness pursuant to the Security Agreement and has requested that the Administrative Agent release its security interest in all right, title and interest in, to and under all of the Trademarks.

NOW, THEREFORE, for good and valuable consideration of the foregoing, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under all of the Trademarks, including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademarks is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Administrative Agent may have obtained in, to and under the Trademarks under the Security Agreement and the Trademark Security Agreements.
