SUPPLEMENT TO PATENT AND TRADEMARK SECURITY AGREEMENT

THIS SUPPLEMENT TO PATENT AND TRADEMARK SECURITY AGREEMENT (this "Supplement"), dated as of March 5, 2021, is made by each of the undersigned grantors (each a "Grantor" and collectively the "Grantors") in favor of JPMORGAN CHASE BANK, N.A., in its capacity as administrative agent (the "Administrative Agent") for the lenders party to the Credit Agreement referred to below.

RECITALS

A. Grantors, the other Loan Parties, the Lenders and the Administrative Agent are parties to that certain Credit Agreement, dated as of December 1, 2020 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"). Capitalized terms used herein have the meanings given to them in the Credit Agreement unless otherwise specified.

B. To induce the Lenders to provide the financial accommodations described in the Credit Agreement, Grantors and the Administrative Agent entered into that certain Patent and Trademark Security Agreement, dated as of December 1, 2020 (as recorded on 12/02/2020 with the Trademark Division of the United States Patent and Trademark Office at REEL/FRAME 007121/0305 and as amended, restated, supplemented or otherwise modified from time to time, the "IP Security Agreement").

C. Grantors have requested that the Administrative Agent modify and supplement certain terms of the IP Security Agreement as set forth herein.

NOW, THEREFORE, in consideration of the premises and of the mutual covenants and agreements herein contained, it is agreed as follows:

1. Supplements to the IP Security Agreement. Schedule II to the IP Security Agreement is hereby supplemented by adding the trademarks set forth on Schedule I hereto ("New Trademarks"), in each case, including the New Trademarks as Patent and Trademark Collateral (as defined in the IP Security Agreement) thereunder.

2. No Other Changes. Except as modified by this Supplement, all of the terms and conditions of the IP Security Agreement shall remain in full force and effect and are hereby ratified and reaffirmed by each Grantor.


