INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement (“**Agreement**”) is entered into as of December 1, 2020 by and between (a) each of the signatories hereto (each, a “**Grantor**” and collectively, the “**Grantors**”) and (b) **JGB Collateral, LLC**, a Delaware limited liability company in its capacity as collateral agent (in such capacity, the “**Agent**”) for the holders of the 8.00% Original Issue Discount Senior Secured Notes due December 1, 2022, in the original aggregate principal amount of \$32,432,000 (collectively, the “**Notes**”) of NewAge, Inc., a Washington corporation (the “**Company**”).

RECITALS

WHEREAS, pursuant to the Purchase Agreement (as defined in the Notes), the Purchasers (as defined in the Purchase Agreement) have severally agreed to extend the loans to the Company, as evidenced by the Notes;

WHEREAS, in order to induce the Purchasers to extend the loans evidenced by the Notes, Agent, Company, Grantors and certain other debtors have executed a Security Agreement dated as of the date hereof (as may be amended, restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”; capitalized terms used but not defined herein shall have the meaning given to such terms in the Security Agreement), pursuant to which each Grantor has granted to Agent, for the ratable benefit of the Purchasers, a security interest in, among other things, its Intellectual Property constituting Collateral (collectively, the “**Intellectual Property Collateral**”) to secure the prompt payment, performance and discharge in full of all of the Company’s obligations under the Notes and other Transaction Documents (as defined in the Purchase Agreement) and the Subsidiary Guarantors’ (as defined in the Purchase Agreement) obligations under the Purchase Agreement; and

WHEREAS, Agent and Grantors desire to enter into this Agreement to more fully evidence the Agent’s security interests in the Intellectual Property Collateral.

NOW, THEREFORE, in consideration of the agreements herein contained and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto hereby agree as follows:

AGREEMENT

- (1) Grant of Security Interest. To secure the Obligations to Agent and Purchasers (collectively, the “**Secured Parties**”), each Grantor grants and pledges to Agent, for the ratable benefit of the Secured Parties, a security interest in all of such Grantor’s right, title and interest in, to and under all Intellectual Property Collateral, including, without limitation:
 - (a) the registered copyrights set forth on Exhibit A attached hereto (the “Copyrights”);
 - (b) the patents and patent applications set forth on Exhibit B attached hereto (the “Patents”);


- (c) the trademarks set forth on Exhibit C attached hereto (the “Trademarks”);
 - (d) Any and all claims for damages by way of past, present and future infringements of any of the rights included above, with the right, but not the obligation, to sue for and collect such damages for said use or infringement of the intellectual property rights identified above;
 - (e) All licenses or other rights to use any of the Copyrights, Patents or Trademarks and all license fees and royalties arising from such use to the extent permitted by such license or rights;
 - (f) All amendments, extensions, renewals and extensions of any of the Copyrights, Trademarks or Patents; and
 - (g) All proceeds and products of the foregoing, including without limitation all payments under insurance or any indemnity or warranty payable in respect of any of the foregoing.
- (2) Recordation. Each Grantor authorizes the Commissioner for Patents, the Commissioner for Trademarks and the Register of Copyrights and any other government officials to record and register this Agreement upon request by Agent.
- (3) Transaction Documents. This Agreement has been entered into pursuant to and in conjunction with the Security Agreement, which is hereby incorporated by reference. The provisions of the Security Agreement shall supersede and control over any conflicting or inconsistent provision herein. The rights and remedies of Agent with respect to the Intellectual Property Collateral are as provided by the Security Agreement and related documents, and nothing in this Agreement shall be deemed to limit such rights and remedies.
- (4) Execution in Counterparts. This Agreement may be executed in counterparts (and by different parties hereto in different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page to this Agreement by facsimile or in electronic (i.e., "pdf" or "tif" format) shall be effective as delivery of a manually executed counterpart of this Agreement.
- (5) Successors and Assigns. This Agreement will be binding on and shall inure to the benefit of the parties hereto and their respective successors and assigns.
- (6) Governing Law. This Agreement and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Agreement and the transactions contemplated hereby and thereby shall be governed by, and construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction).




