TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this “Agreement”) is entered into on this 18th day of February, 2021, by and among **ESTERLINE TECHNOLOGIES CORPORATION** a Delaware corporation, with its principal place of business at 1301 East 9th Avenue, Suite 3000, Cleveland, Ohio 44114 (the “Assignor”), and **TREALITY SVS LLC**, a Delaware limited liability company, with its principal place of business at 600 Bellbrook Avenue, Xenia, Ohio 45385 (the “Assignee”).

NOW, THEREFORE, in consideration of one dollar (\$1.00) and other good and valuable consideration, the full receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby, the parties hereby agree as follows:

1. Assignment. The Assignor hereby irrevocably, fully, and unconditionally grants, sells, assigns, transfers, conveys, sets-over and delivers to the Assignee, free and clear of all Liens, all of the Assignor’s right, title and interest in and to the Trademarks, together with the goodwill associated with the Trademarks, and the registrations issuing therefor, including all rights to damages and profits, due or accrued, arising out of past infringements of said Trademarks, and the right to sue for and recover the same.


2. Cooperation and Recordation. The Assignor hereby agree to cooperate with the Assignee, as reasonably necessary to give full effect to and perfect the rights of the Assignee in the Trademarks, and the Assignor and Assignor agree to execute and deliver all documents and to take all such other actions as the Assignee, Assignor or their respective successors or assigns, may reasonably request to effect the terms of this Agreement.
