

PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS

This PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Partial Release") is granted as of March 4, 2021 by PATHLIGHT CAPITAL LP, as administrative agent and collateral agent for its own benefit and the benefit of the other Credit Parties (as defined in the Security Agreement referred to below), having an office at 18 Shipyard Drive, Suite 2C, Hingham, Massachusetts 02043 (the "Grantee"), in favor of SAKS INCORPORATED, a Tennessee corporation, as a grantor ("Saks Incorporated") and SAKS & COMPANY LLC, a Delaware limited liability company, as a grantor ("Saks & Company" and together with Saks Incorporated, the "Grantors");

WHEREAS, the Grantors, among others, have executed and delivered a Security Agreement, dated as of November 25, 2020 (as amended, modified, supplemented or restated from time to time, the "Security Agreement"), in favor of the Grantee, to secure the satisfactory performance and payment of all of the Grantors' Secured Obligations, as such term is defined in the Security Agreement;

WHEREAS, in conjunction with the security interest granted to the Grantee under the Security Agreement, the Grantors have executed and delivered a Grant of Security Interest in Trademarks, dated as of November 25, 2020 (as amended, modified, supplemented or restated from time to time, the "<u>Trademark Agreement</u>"), to the Grantee which was recorded with (a) the United States Patent and Trademark Office (the "<u>PTO</u>") on November 25, 2020, at Reel 7115 and Frame 0335, and (b) the Canadian Intellectual Property Office (the "<u>CIPO</u>") on or about January 26, 2021;

WHEREAS, the Grantors, among others, have entered into that certain Amended & Restated Asset Transfer and Contribution Agreement, dated as of March 4, 2021 (the "Asset Contribution Agreement") with Saks.com LLC, a Delaware limited liability company ("Saks.com") pursuant to which, *inter alia*, the Grantors have agreed to transfer to Saks.com certain assets including intellectual property; and

WHEREAS, in connection with the Asset Contribution Agreement, the Grantors have requested that that the Grantee release and discharge fully its interest in the trademarks, service marks, trade names, trade dress and other similar designations of source or origin set forth in <u>Schedule A</u> annexed hereto together with all registrations, applications and renewals for, any of the foregoing and all associated goodwill (collectively, the "<u>Specified Trademark Collateral</u>").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Grantee does hereby release and discharge, without any representation or warranty, any and all liens and security interests it may have in and to the Specified Trademark Collateral.

The Grantee hereby authorizes and requests that the (a) PTO, and (b) the CIPO note and record the present Partial Release against the Specified Trademark Collateral.

Except for the release of Specified Trademark Collateral, all terms and provisions of the Trademark Agreement shall remain in full force and effect. Nothing contained herein shall in any way impair the validity or enforceability of the Trademark Agreement, as modified hereby, or

alter, waive, annul, vary, affect, or impair any provisions, conditions, or covenants contained therein or any rights, powers, or remedies granted therein. Any lien and/or security interest granted in any Trademarks (as defined in the Security Agreement) pursuant to the Trademark Agreement or the Security Agreement shall remain unchanged and in full force and effect except as specifically released hereby and shall continue to secure the payment and performance of all of the Secured Obligations (as defined in the Security Agreement).

THIS PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
