## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of March 8, 2021 (the “Effective Date”), is made by OWL ROCK CAPITAL CORPORATION, as collateral agent for the Secured Parties (in such capacity, the “Agent”), in favor of INVINCEA, INC., REFLEXION NETWORKS, INC., ROOK SECURITY, LLC, SOPHOS INC. and SOPHOS LIMITED (each a “Grantor,” and collectively the “Grantors”). All capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed to them in the Trademark Security Agreement (whether defined therein or by reference to another agreement).

WHEREAS, pursuant to that certain Second Lien Security Agreement by and among the Grantors, the Agent, and certain other parties, dated as of March 5, 2020 (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), the Grantors executed and delivered a Trademark Security Agreement, dated as of July 3, 2020 (the “Trademark Security Agreement”), which was recorded in the United States Patent and Trademark Office (“USPTO”) on July 6, 2020 at Reel/Frame 6990/0686 (with respect to Invincea, Inc.), at Reel/Frame 6990/0699 (with respect to Reflexion Networks, Inc.), at Reel/Frame 6990/0723 (with respect to Rook Security, LLC), at Reel/Frame 6990/0751 (with respect to Sophos Inc.), and at Reel/Frame 6990/0764 (with respect to Sophos Limited);

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, each Grantor granted to the Agent for the ratable benefit of the Secured Parties a security interest (the “Security Interest”) in and to all of such Grantor’s right, title and interest in and to the following, except for any Excluded Property, whether then existing or thereafter arising or acquired from time to time: (i) all Trademarks, including the registration and applications set forth in Schedule A hereto, together with the goodwill symbolized thereby (but excluding any intent-to-use Trademark application prior to the filing of a “Statement of Use” or “Amendment to Allege Use” with respect thereto, to the extent, if any, that, and solely during the period, if any, in which, the grant of a security interest therein would impair the validity or enforceability, or result in the voiding, of such intent-to-use Trademark application or any registration issuing therefrom under applicable federal law); (ii) all reissues, divisionals, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing; (iii) all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto; (iv) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, and the right, but not the obligation, to sue for and collect, or otherwise recover, such damages and injunctive relief; and (v) any and all proceeds of, collateral for, income, royalties and other payments then or thereafter due and payable with respect to, and supporting obligations relating to, any and all of the Collateral or arising from any of the foregoing (collectively, the “Trademark Collateral”); and

WHEREAS, the Agent and the Grantors acknowledge that the requirements for releasing the Security Interest in the Trademark Collateral have been met.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent, hereby (i) terminates and cancels the Trademark Security Agreement, (ii) releases, discharges, terminates and cancels the Security Interest in and to the Trademark Collateral, and (iii) re-assigns to each Grantor any right, title or interest it may have in the Trademark Collateral of such Grantor, in each case without recourse to the Agent and without representation or warranty of any kind.

Each Grantor, or any successor to such Grantor (including any person or entity hereafter having any right, title or interest in or to the Trademark Collateral of such Grantor), is hereby authorized to record this Release in the USPTO.
