**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

**THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (this "Release") is made this [9<sup>th</sup>] day of March, 2021, by SILICON VALLEY BANK, as lender ("Lender").

**WHEREAS**, reference is made to a certain Intellectual Property Security Agreement dated as of October 18, 2017 and recorded with the United States Patent and Trademark Office on November 7, 2018, at Reel 006537 Frame 0044 (as amended, restated, amended and restated, supplemented and/or modified to date, the "IP Security Agreement"), by Titus Group, Inc., a Delaware corporation ("Grantor") in favor of Lender. **NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby (i) terminates the IP Security Agreement, (ii) releases any and all liens on, and its security interest in and to the Intellectual Property Collateral arising under the IP Security Agreement, including, but not limited to, the Trademarks set forth on Schedule A attached hereto, and (iii) authorizes the recordation of this Release by Grantor or their designee with the United States Patent and Trademark Office.

This Release shall be governed by and construed in accordance with the laws of the State of California without regard to conflicts of law principles.
