**QUITCLAIM TRADEMARK ASSIGNMENT AGREEMENT**

This QUITCLAIM TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment"), dated 3.1.21, 2021 (the "Effective Date"), is made by and between High Peak Sales, Inc. Grantee shall not use the Mark, or any colorable variation thereof, including with respect to Grantee's business or in connection with Grantee's goods and/or services, on or after the Effective Date of this Assignment.
