Assignor agrees to, and does hereby, assign to Assignee, its successors, legal representatives and assigns, and Assignee does hereby accept, all of Assignor's right, title, and interest in and to any claims, whether known or unknown, suspected or unsuspected, of any nature, including choses in action, that Assignor has or may have against any party for past, present, and future infringement of the Marks and Mark Applications, as fully and entirely as the foregoing would have been held and enjoyed by the Assignor, had this assignment not been made, and acknowledges receipt of fair and adequate consideration for this Assignment.


