TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of March 10, 2021 (“Release”), is made by BMO Harris Bank N.A., as administrative agent (“Agent”), in favor of AllOver Media, LLC, a Delaware limited liability company, AllOver Media Acquisitions, LLC, a Georgia limited liability company, and AllOver Media Mobile, LLC, a Delaware limited liability company (each a “Debtor”, and collectively, the “Debtors”).

WHEREAS, pursuant to that certain Security Agreement dated as of March 16, 2015 (as amended, modified or restated from time to time, the “Security Agreement”) by and among the Debtors, Agent, and others party thereto and the Trademark Collateral Agreement dated as of March 16, 2015 (“Trademark Collateral Agreement”) by and among the Debtors and Agent, Debtor granted to the Agent, for the benefit of the Secured Creditors, a continuing security interest in and to all right, title and interest of such Debtors in, to and under the Trademark Collateral; and

WHEREAS, the Trademark Collateral Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on March 17, 2015 at Reel 5480 Frame 0561.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Agent, on behalf of the Secured Creditors, and Debtors agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or Trademark Collateral Agreement.

SECTION 2. Termination and Release. Agent, on behalf of the Secured Creditors, hereby:

(a) terminates the Trademark Collateral Agreement;

(b) terminates, cancels, forever discharges, and releases the continuing security interest in and to all right, title and interest of Debtors in, to and under the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto;

(c) represents and warrants that it has full authority to execute and deliver this Release; and

(d) authorizes the recordation of this Release by Debtor or any of its designees with the USPTO at Debtors’ expense.

SECTION 3. Further Assurances. Agent, at Debtors’ expense, hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the security interest release contemplated herein. To the extent that any other filings with any other governmental authority have been made with respect to any of the Trademark Collateral, Agent will, at Debtors’ expense, execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.

IN WITNESS WHEREOF, the Agent, on behalf of the Secured Creditors, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
