RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of March 11, 2021 (“Effective Date”), by **AB PRIVATE CREDIT INVESTORS LLC**, in its capacity as collateral agent for the Secured Parties (in such capacity, the “Collateral Agent”), in favor of **ARSALON TECHNOLOGIES, LLC**, a Kansas limited liability company, **DATABANK HOLDINGS LTD.**, a Texas limited partnership, **EDGE HOSTING, LLC**, a Maryland limited liability company, **FUSEAPP, LLC**, a Utah limited liability company, **INTEGRATECHS, LLC**, a Utah limited liability company, **HRS INTERNET, LLC**, a Indiana limited liability company, and **LIGHTBOUND, LLC**, a Indiana limited liability company, (each of the foregoing, a “Pledgor”; and collectively, the “Pledgors”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Second Lien Security Agreement (as defined below) or, if not defined therein, in the Second Lien Credit Agreement (as defined below).

WHEREAS, reference is made to that certain Second Lien Credit Agreement, dated as of October 3, 2017 (as amended, amended and restated, supplemented, waived, renewed, replaced or otherwise modified from time to time, the “Credit Agreement”), by and among DB DataCenter Holdings Inc., a Delaware corporation (the “Company”), DataBridge Parent, Inc., a Delaware corporation (“Holdings”), certain subsidiaries of Holdings from time to time party thereto, the lenders from time to time party thereto and the several agents party thereto, including the Collateral Agent.

WHEREAS, pursuant to the Credit Agreement, the Pledgors and Collateral Agent entered into that certain Second Lien Security Agreement dated as of October 3, 2017 (as amended, amended and restated, supplemented, waived, renewed, replaced or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, each Pledgor and Agent entered into (i) that certain Second Lien Trademark Security Agreement, dated as of October 3, 2017, which was recorded with the United States Patent and Trademark Office, (the “USPTO”) on October 11, 2017 at Reel 6180, Frame 0001; (ii) that certain Second Lien Trademark Security Agreement, dated as of September 30, 2019, which was recorded with the USPTO on September 30, 2019 at Reel 6758, Frame 0540; and (v) that certain Amended and Restated Second Lien Trademark Security Agreement, dated as of January 31, 2020, which was recorded with the USPTO on January 31, 2020 at Reel 6854, Frame 0111 (each as amended, restated, amended and restated, supplemented, or otherwise modified and in effect from time to time, collectively, the “Trademark Security Agreements”);

WHEREAS, pursuant to the terms of the Trademark Security Agreements, each Pledgor granted, assigned, and pledged to Collateral Agent, for the benefit of the Secured Parties, to secure the Secured Obligations, a continuing security interest in and to all of such Pledgor’s right, title, and interest in and to all of its Trademarks and Goodwill associated with such Trademarks whether then owned or thereafter acquired or arising, including without limitation those Trademarks listed on **Schedule I** attached hereto (the “Trademark Collateral”); and

WHEREAS, Collateral Agent now desires to release its security interest in the Trademark Collateral, including, without limitation, the trademark registrations and applications listed on **Schedule I** hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby covenants and agrees as follows:



Terminates, releases, and, discharges its security interest in the Trademark Collateral granted pursuant to the Trademark Security Agreements, and reassigns to each Pledgor all right, title, and interest that Collateral Agent may have in the Trademark Collateral pursuant to the Trademark Security Agreements; and

2. Agrees to duly execute, acknowledge, procure, and deliver any further documents and to do such other acts, in each case at the Pledgors expense, as may be reasonably necessary to effect the release of the security interest in the Trademark Collateral contemplated hereby.
