**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (this “Trademark Release”) is made as of March 10, 2021, by **GOLUB CAPITAL MARKETS LLC**, a Delaware limited liability company (in such capacity, together with its successors and assigns in such capacity, the “Administrative Agent”) in favor of **PSP FRANCHISING, LLC**, a Delaware limited liability company with an address at 17197 N. Laurel Park Drive, Suite 402, Livonia, Michigan 48152 (the “Grantor”).

W I T N E S S E T H:

WHEREAS, the Grantor entered into a certain trademark security agreement, dated as of December 12, 2018 (the “First Trademark Security Agreement”), with the Administrative Agent, notice of which was recorded on December 13, 2018 at the United States Patent and Trademark Office (the “USPTO”) at **Reel 6552, Frame 0820**.

WHEREAS, the Grantor entered into a certain trademark security agreement, dated as of December 23, 2019 (the “Second Trademark Security Agreement”; and together with the First Trademark Security Agreement, the “Trademark Security Agreements”), with the Administrative Agent, notice of which was recorded on December 30, 2019 at the USPTO at **Reel 6827, Frame 0625**.

WHEREAS, pursuant to the Trademark Security Agreements, the Administrative Agent has a continuing Lien on and security interest in all of the Grantor’s right, title and interest in, to and under the Grantor’s Trademark Collateral, including without limitation the Trademarks listed in **Schedule A**.

WHEREAS, the Administrative Agent has agreed to terminate and release its Lien on and security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the lenders in association with Lien and security interest, hereby agrees as follows:

1. **Defined Terms**. Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreements.
2. **Termination and Release of Lien on and Security Interest in Trademark Collateral**. The Administrative Agent, for itself and on behalf of the Secured Parties, hereby irrevocably terminates the Trademark Security Agreements and irrevocably releases, terminates and discharges their mortgage, pledge, hypothecation, Lien on and security interest in the Trademark Collaterals, including the trademark registrations and applications set forth in **Schedule A**, and hereby assigns, transfers and conveys to the Grantor any and all of their right, title, and interest in, to and under the Trademark Collaterals.
3. **Recordation**. The Administrative Agent hereby authorizes the Grantor or the Grantor’s authorized representative, at the Grantor’s sole cost and expense, to record this Trademark Release with the USPTO. The Administrative Agent authorizes and requests that the Commissioner of the United States Patent and Trademark Office and any other applicable government authority record this Trademark Release.

4. Governing Law. This Trademark Release and the rights and obligations of the parties hereto shall be governed by and construed and interpreted in accordance with the laws of the State of New York and shall be binding upon the parties' representatives, successors, assigns and transferees.
