ASSIGNOR agrees to perform all affirmative acts which may be necessary or desirable to record and/or perfect the above-described transfer of trademark rights or to maintain said registrations before the U.S. Patent and Trademark Office at ASSIGNEE's expense, as well as to cooperate with ASSIGNEE in obtaining and/or providing information required in any proceedings relating to said trademark.

ASSIGNOR hereby grants to ASSIGNEE the authority and power to insert on this instrument any further identification, which may be necessary or desirable for purposes of recordation with the U.S. Patent and Trademark Office.
