**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the “Release”) is made as of February 16, 2021, by J.P. MORGAN CHASE BANK, N.A. (“Lender”) in favor of JADCORE, LLC, an Indiana limited liability company (“Borrower”).

**WITNESSETH:**

WHEREAS, pursuant to that certain Trademark Security Agreement dated July 7, 2017, by and among Borrower and Lender (the “Security Agreement”), recorded on July 17, 2017, at Reel No. 6106, Frame 0387, United States Patent and Trademark Office, Borrower granted a security interest in certain Trademarks (as defined in the Security Agreement) in favor of Lender to secure certain debt owing from Borrower to Lender;
