TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Termination and Release"), dated as of March 15, 2021, by GLAS Americas LLC, as successor to The Bank of Nova Scotia ("Scotiabank") as collateral agent (in such capacity, the "Collateral Agent").

WITNESSETH:

WHEREAS, reference is made to that certain Notice of Successor Agent and Assignment of Security Interest (Trademarks), dated as of March 11, 2020, among The Bank of Nova Scotia, as the resigning Collateral Agent under the Credit Agreement, GLAS AMERICAS LLC, the successor Collateral Agent under the Credit Agreement and CPI Card Group, Inc, CPI Card Group - Minnesota, Inc. and CPI Card Group - Tennessee, Inc.;

WHEREAS, pursuant to certain Trademark Security Agreements and Notice of Successor Agent and Assignment of Security Interest (Trademarks) recorded with the Trademark Division of the United States Patent and Trademark Office on August 20, 2015, March 12, 2020 and February 9, 2021, at Reel/Frame 5603/0825, Reel/Frame 5603/0810, Reel/Frame 5603/0832, Reel/Frame 6890/0115, and Reel/Frame 7188/0147 (the "Trademark Security Agreements"), a lien on and security interest (the "Security Interest") was granted by CPI CG Inc., CPI Card Group Inc., CPI Card Group - Minnesota, Inc. and CPI Card Group - Tennessee, Inc. (collectively, the "Grantors") to the Collateral Agent in certain collateral, including but not limited to the trademarks set forth on Schedule 1 hereto (the "Trademarks");

WHEREAS, the Collateral Agent now desires to terminate and release the entirety of its Security Interest in the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Collateral Agent hereby agrees as follows:

1. Definitions. Capitalized terms not defined herein shall have the meanings set forth in the Trademark Security Agreements.
2. Release of Security Interest. The Collateral Agent, without representation, warranty or recourse, hereby terminates the Trademark Security Agreements and terminates, releases and discharges any and all Security Interest in the Trademarks, and any right, title or interest of the Collateral Agent in such Trademarks shall hereby cease and become void.
3. Recordation. The Collateral Agent authorizes each Grantors and its designees to record this Termination and Release with the United States Patent and Trademark Office or any other applicable governmental authority at such Grantor's expense.
