## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS is dated as of March 16, 2021, by COMVEST CREDIT PARTNERS V, L.P., as administrative agent for the Lenders referred to in the Security Agreement referenced below (in such capacities, together with its successors and assigns in such capacities, the "Agent") in favor of PAYMENT CONCEPTS LLC, an Oklahoma limited liability company having an office at 4343 S. 118th East Avenue, Suite 220, Tulsa, OK 74146 (the "Grantor").

WHEREAS, Agent recorded the Trademark Agreement on September 25, 2019 at Reel 6754, Frame 0105 with the United States Patent and Trademark Office; and

WHEREAS, Grantor has requested that Agent release its security interests in the Trademarks listed on Schedule I hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby fully discharges, releases and terminates its security interests in and liens on the Trademarks listed on Schedule I hereto and all other Trademark Collateral (as defined in the Trademark Agreement) and any right, title or interest of the Agent in the foregoing under the Security Documents shall hereby cease and become void.


