

# **Intellectual Property Assignment Agreement**

This IP assignment agreement ("Agreement") is executed on January 5th 2021, ("Date of the Agreement") by and between:

- (1) Laboratoires Théa, a French SAS company, incorporated with the registre du commerce et des sociétés of Clermont-Ferrand, France, under number 390 813 988 ("Transferee");
- (2) Professor Telfion Emlyn James, a British citizen, residing 1 Heath Villas, Halifax, UK, England ("TJ"); and
- (3) The Eyebag Company Limited, an English private limited company, incorporated with the Companies House under number 05110816 ("Eyebag");

(TJ and Eyebag shall be referred collectively as the "Transferors" and individually as a "Transferor". The Buyer and the Sellers shall be referred collectively to as the "Parties" and individually as a "Party".).

#### Recitals:

- (A) On the Date of the Agreement, the Transferee and the Transferors executed an asset purchase agreement ("APA") pursuant to which the Transferors agreed to sell to the Transferee, which accepted, certain assets, including the Transferred Intellectual Property Rights, as such term is defined in the APA.
- (B) In accordance with <u>Article 5.1.1</u> of the APA, the Parties agreed to execute this Agreement for the purpose of the formalities that the Transferee, with the assistance of the Transferor, will have to carry out in relation to the assignment of the Transferred Intellectual Property Rights from the Transferors to the Transferee before the relevant Governmental Authorities, as such term is defined in the APA.

### Now, therefore, it has been agreed as follows:

# 1. Definitions and interpretation

- 1.1 Except as set forth in this Agreement, capitalized terms used in this Agreement shall have the meaning set forth in the APA.
- 1.2 Except as set forth in this Agreement, this Agreement shall be interpreted in accordance with the provisions of <u>Article 1.2</u> of the APA.

## 2. Assignment of the Transferred Intellectual Property Rights

- 2.1 The Parties agreed and acknowledged that the conditions of the Sale contemplated by the APA are fulfilled on the Date of the Agreement.
- 2.2 The Sale is therefore executed and the Transferee shall be the full owner of the Transferred Intellectual Property Rights.
- 2.3 Schedule 2.3 of the APA includes an indicative list of the Transferred Intellectual Property Rights assigned by the Transferor to the Transferee under the Sale as such term is defined in the APA.

It is expressly reminded, for the avoidance of doubt, that it is agreed between the Parties that any ideas which TJ developed prior to the conclusion of the APA and any intellectual property relating thereto shall fall outside the scope of this Agreement and of that of the APA. TJ will nevertheless offer the right of first refusal on such ideas and intellectual property to LT. Should an agreement be concluded with LT on terms acceptable to TJ, TJ will cause for all relevant information pertaining to the said ideas and intellectual property, which will be held safely in the hands of TJ's patent agent, to be released to LT.

#### 3. Consideration

The assignment of the Transferred Intellectual Property Rights is made in consideration of a share of the Purchase Price, as set out in the APA.

#### 4. Formalities and Assistance of the Transferors

From the Date of the Agreement until the end of the Transition Period as such term is defined in the APA, the Transferors shall give full and good-faith assistance to the Transferee, including the provision of any documents that the Transferee may request for, for the purpose of the formalities that the Transferee will have to carry out before the relevant Governmental Authorities for the completion of the assignment of the Transferred Intellectual Property Rights, including the registration of the Transferee as the exclusive owner of the Transferred Intellectual Property Rights before public registries and patent and trademark offices in territories covered by the Transferred Intellectual Property Rights.

#### 5. Brexit

The Parties agreed that the withdrawal of the United Kingdom from the European Union ("Brexit") shall have no effect on their intentions to execute and perform the transactions contemplated by the APA and the Agreement, including the assignment of the Transferred Intellectual Property Rights by the Transferors to the Transferee. If the Brexit has a material effect on the assignment of Transferred Intellectual Property Rights, such as a significant cost increase to the assignment, the Parties shall negotiate in good faith an adjustment or amendment to the terms of the Agreement (or the APA) in order to preserve each Party's intentions and rights hereunder. Furthermore, the Transferors undertake to provide the same assistance defined in Article 4 of this Agreement for the completion of the formalities (or other actions to be carried out) associated with the assignment of the Transferred Intellectual Property Rights.

#### 6. Absence of Novation

- 6.1 The Agreement is executed without prejudice to the provisions of the APA and without effecting any novation.
- 6.2 All the provisions of the APA remain applicable between the Parties. In the event of a discrepancy between the provisions of the Agreement and the provisions of the APA, the provisions of the APA shall prevail.
- 6.3 The Parties agree that the existence and validity of this Agreement is conditional upon the APA being concluded and executed simultaneously.

#### 7. Language

The Agreement is executed in English. Any translation of the Agreement made for the completion of the formalities shall be construed for information purposes only. In case of discrepancy between the English version and another translation of such English version, the English version of this Agreement shall prevail.

#### 8. Governing Law

The Agreement is governed by French law.

#### 9. Litigation; Jurisdiction

Any dispute arising in connection with the Agreement shall be submitted to the jurisdiction of the courts within the Paris Court of Appeal, France (tribunaux du ressort de la Cour d'appel de Paris).

### 10. Electronic signature

Pursuant to article 1367 of the French Civil Code, the Parties acknowledged and agree that the Agreement is executed by electronic signature by use of DocuSign. Each electronic signature shall be considered as an original signature for all purposes and shall have the same force and



effect as an original signature.
