INTELLECTUAL PROPERTY SECURITY INTEREST RELEASE AGREEMENT (this "**Agreement**"), dated as of March 15, 2021, between PITTSBURGH PENGUINS LP, a Pennsylvania limited partnership (the "**Borrower**" or the "**Grantor**"), and SUMITOMO MITSUI BANKING CORPORATION, as collateral agent (in such capacity, the "**Collateral Agent**") for the Secured Parties (as defined in the Security Agreement referred to below).

WITNESSETH

WHEREAS, the Borrower is a party to that certain Third Amended and Restated Credit Agreement, dated as of March 16, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "**Credit Agreement**"), with, among others, PNC Bank, National Association, as administrative agent (in such capacity, the "**Administrative Agent**"), the Collateral Agent and the Lenders from time to time party thereto;

WHEREAS, in order to induce the Lenders to make Loans, the Grantor entered into that certain Amended and Restated Borrower Security Agreement, dated as of December 29, 2010 (as supplemented by that certain Confirmation of Security Interests in Intellectual Property Collateral, dated as of March 16, 2016, among the Grantor, HoldCo, TeamCo, ArenaCo GP, Community Rink GP and the Collateral Agent and as further amended, restated, supplemented or otherwise modified from time to time, the "**Security Agreement**"), as recorded at the United States Patent and Trademark Office under Reel/Frame Numbers 4095/0100, 4449/0564, and 5161/0014, pursuant to which the Grantor granted to the Collateral Agent as security for the Obligations a continuing security interest (the "**Security Interest**") in certain Collateral, including the Copyrights listed on Schedule 1 attached hereto (the "**US Copyright Collateral**"), the Trademarks listed on Schedule 2 attached hereto (the "**US Trademarks Collateral**") and the Trademarks listed on Schedule 3 attached hereto (the "**Canadian Trademarks Collateral**"), and together with the US Copyright Collateral and the US Trademarks Collateral, the "**IP Collateral**");

WHEREAS, the Grantor's obligations under the Security Agreement have been completed and discharged; and

WHEREAS, each of the Grantor and the Collateral Agent are entering into this Agreement to release the Security Interest in and to the IP Collateral and assign any rights the Collateral Agent may have acquired in the IP Collateral by the Security Agreement back to the Grantor.

NOW, THEREFORE, in consideration of the agreements set forth below, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. **Definitions.** Capitalized terms used but not otherwise defined herein have the meaning specified in the Credit Agreement or the Security Agreement, as applicable.

2. **Release.** As of the date hereof, the Collateral Agent hereby releases the Security Interests in the IP Collateral (the "**Released Security Interests**") and assigns to the Grantor any remaining Security Interest the Collateral Agent may have in the Grantor's right, title and interest in the IP Collateral.

3. **Counterparts.** This Agreement may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page of this Agreement by facsimile or other electronic transmission (such as a PDF file) shall be effective as delivery of a manually executed counterpart of this Agreement.

4. **Governing Law.** THIS AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK.


