TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of March 16, 2021 (“Release”), is made by Bank of America, NA. (“Lender”), in favor of Lief Organics, LLC, a California limited liability company (“Grantor”).

WHEREAS, pursuant to that certain Loan Agreement dated as of March 29, 2019 (as amended or modified from time to time, the “Loan Agreement”) by and among the Grantor and Lender and the Trademark Security Agreement dated as of April 5, 2019 (“Trademark Security Agreement”) by and among the Grantor and Lender, Grantor pledged and granted to the Lender a security interest in and to all of the right, title and interest of Grantor in, to and under the Trademark Collateral; and

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender and Grantor agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Loan Agreement or Trademark Security Agreement.

SECTION 2. Termination and Release. Lender, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the security interest in and to all of the right, title and interest of Grantor in, to and under the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Loan Agreement or Trademark Security Agreement; and


(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.
