**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this “*Release*”), dated as of March 15, 2021, is made by Fifth Third Bank, National Association, as collateral agent and administrative agent for the Secured Parties (in such capacity and together with any successors and assigns in such capacities, the “*Collateral Agent*”), in favor of Cumberland Consulting Group, LLC (the “*Grantor*”) under that certain Intellectual Property Security Agreement, dated as of July 23, 2018 (as may have been amended, restated, supplemented or otherwise modified from time to time, the “*IP Security Agreement*”) by and among the Grantor and the Collateral Agent.

WHEREAS, pursuant to the IP Security Agreement, Grantor granted to the Collateral Agent a security interest in all of Grantor’s right, title and interest in, to and under the collateral described in detail therein (such collateral, the “*IP Collateral*”);

WHEREAS, the Grantor requests that the Collateral Agent release, discharge, terminate and cancel its security interest in and to the IP Collateral, including but not limited to the trademark registrations and applications listed on Schedule A attached hereto, together with the goodwill connected with the use of and symbolized thereby and all extensions and renewals thereof;


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent, without recourse, representation or warranty of any kind or nature, and at the Grantor’s sole cost and expense, hereby releases, discharges, terminates and cancels its remaining security interest in and to the IP Collateral.

1. The Collateral Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.
2. The validity, interpretation and enforcement of this Release and any dispute arising out of the relationship between the parties hereto, whether in contract, tort, equity or otherwise, shall be governed by and construed in accordance with the laws of the State of New York.
3. Capitalized terms used but not defined herein shall have the meanings given to them in the IP Security Agreement.
